

CIVIL WORKS INVESTMENT TRENDS (EXCLUDES SUPPLEMENTAL FUNDING)







Significant Changes in Execution Tracking:

1.Use of PowerBI dashboards to focus on CW Milestone Execution (both planning side and execution side).

2.Significant new module for Commanders to get early schedule and financial information to decision makers – CCIR#8.

- 4.Focusing on schedule commitments; training on tool usage and Project Controls Offices.
